 - All purchases are made by credit cards (Visa or M/C),UnionPay,cash or E.P.S.
 - All forms of advertising and printed material must be submitted and approved by the Company prior to use.
 - I MAY CANCEL THIS AGREEMENT AT ANY TIME EFFECTIVE UPON MAILING WRITTEN NOTICE TO FLP. If I should elect to cancel, all products which I purchased from FLP and which are in my possession in a resalable condition, shall be repurchased in accordance with FLP’s company policies and procedures.
 - I may be terminated by the Company for failure to comply with this Agreement, the marketing plan, the rules, regulations and the code of ethics or subsequent policies of the Company.
 - This agreement shall be governed by the laws of Hong Kong and I consent to the non-exclusive jurisdiction of the courts of Hong Kong.

NOTICE TO FBO AND APPLICANTS
PERSONAL DATA (PRIVACY) ORDINANCE

How we will use your personal information

From time to time it is necessary for you to provide us with your personal data for purposes related to your distributorship or your application to become a Forever Living Products FBO. These purposes may include :

- the processing of your FBO application;

- other purposes directly relating to any of the above.

To whom we may transfer your personal information

Where permitted by the provisions of any applicable law, your information may be :

- made available to appropriate persons in our parent and affiliated companies, local and overseas;
